# Middletown Cemetery

**RULES & REGULATIONS**  
**Approved by Cemetery Board**  
**December 18, 2013**  
**Adopted by City Council**  
**date**

*The City of Middletown Cemetery is an historic cemetery where pioneers of this area are buried. Although burials at The City of Middletown Cemetery are not restricted to descendants of these pioneers, we hope that you will join us in honoring their memory and preserving the quiet dignity of this sacred place. It is with this intention that we have written these rules and regulations for governing the cemetery.*

## **PURPOSE**

The following rules and regulations have been adopted as a guide for the use and management of the *Middletown Cemetery* and surrounding grounds. The rules and regulations will help protect all who have an interest here. All owners of interment rights, visitors, and contractors performing work on the property are subject to these rules and regulations together with all amendments or alterations as shall be adopted by the Middletown City Council from time to time.

## **GLOSSARY**

**Cemetery:** a burial ground

**City:** The City of Middletown

**Interment:** a burial right

**Lot:** an area containing more than one (1) burial space

**Monument:** an upright grave marker, sometimes referred to as a headstone

**Owner(s):** the person(s) who has/have interment rights

**Sepulture:** the act of interment; burial

**Site:** includes the Cemetery, and any surrounding grounds owned by the City of Middletown.

**Space:** one burial site (not the above definition of 'site')

**Urn:** a container used for cremated remains

## **GENERAL RULES AND REGULATIONS**

1. The City may, and it hereby expressly reserves the right to adopt new rules and regulations or amend, alter and/or repeal any rule, regulations and/or article, section or paragraph in these Rules and Regulations. Special cases may arise in which a literal enforcement of the rule may impose unnecessary hardship. The City, therefore, reserves the right, without notice, to make exceptions, suspensions or modifications of any of the Rules and Regulations when, in its sole judgment, such action appears advisable. Any such temporary exception, suspension or modification of the Rules & Regulations by the City shall not be construed as affecting the general application of such Rules and Regulations.

2. The City retains, for the benefit of all interment right owners, full and complete supervision, control and management of the land, buildings, improvements, roads, walks, utilities, development, books and records, and the full and complete authority, rights and privileges to

make, change, administer and enforce all rules and regulations and restrictions not inconsistent with the laws of the State of Ohio.

3. All burial spaces in the Cemetery shall be used in accordance with the provisions of the laws of the State of Ohio and shall not be used for any other purpose than as a burial place for human remains.

4. Visiting hours are from 8 a.m. to 5 p.m. every day. Any person who is found on the Cemetery grounds outside these hours, without prior authorization either from the City, will be considered a trespasser.

5. Owners of burial spaces do not own the property but simply acquire the right of interment (sepulture) in that specified location.

6. No person, other than agents of the City, shall be allowed to perform any work within the Cemetery without permission of the City.

7. The City shall direct all work and improvements within the grounds and upon all burial spaces before and after interments have been made.

8. The City will not be responsible for any loss, damage or injury occurring within or without the Cemetery.

9. Vehicles and equipment used to perform the business of the Cemetery shall take precedence over vehicles being driven by Cemetery visitors. The speed limit within the Cemetery is five (5) miles per hour. Visitor parking is allowed only on the gravel roads.

10. No form of recreation is permitted in the Cemetery. Children under the age of 18 must be accompanied by an adult when visiting the Cemetery.

11. Bicycles, skates, snowmobiles, horses, etc., may not be used in the Cemetery. Dogs must be on a leash.

12. Bringing alcoholic beverages or illegal drugs into the Cemetery and/or site is strictly prohibited.

13. The City shall have the right to enter upon or use any adjoining burial space or lot to carry out its duties as to interments, placement of monuments, etc., without prior notice to the owner thereof.

14. No signs, notices, or advertisements of any kind shall be allowed on the Cemetery site unless placed by the City.

#### **INTERMENT & FUNERAL REGULATIONS**

15. All burials must be authorized by the City.

16. City personnel will locate the burial spaces when needed.

17. Interments into a burial space are restricted to those entitled to interment therein according to these rules and regulations.
18. Interment in a lot or burial space shall be allowed if space is available.
19. Because of environmental issues and concerns, no interment of a casket or urn can be made unless there has been provided an outer container with strength to resist deterioration. Outer burial containers must be constructed of material meeting the standards of the funeral industry.
20. The scattering of cremated remains in the Cemetery is prohibited.
21. The City does not participate in funeral arrangements other than the location of, or opening and closing of, burial spaces.

## **MONUMENTS**

22. Honorary military flat markers of granite must be placed immediately behind the headstone monument.
23. In the event a monument is placed where it is necessary to temporarily remove it for an interment or disinterment, the City will have the right to remove the monument without notice to the burial space owner. It will be reinstalled to its original position when work is completed.
24. The City may, at its own expense and without any liability, correct any error that may occur in the placing of a monument.
25. No photographs or porcelain material may be incorporated into any monument. No glass, protective glass or breakable material of any kind will be allowed on any monument.

## **FLOWER & DECORATION REGULATIONS**

26. The City reserves the right to remove all flowers, wreaths, or other decorations from burial spaces as soon as they become unsightly. The grounds will be cleared of decorations by the end of April and on an as needed basis.
27. Landscaping, maintenance, and/or removal of any plants, bushes or trees will be under the supervision of the City.

**FOUNDATIONS/MARKERS**

1. The cost of a foundation is shown on the Rate Schedule and is subject to change. Payment must be made at time of order.
2. All grave markers must be commercially manufactured and engraved.
3. Monuments and flush mounted markers will be permitted in standard granite, bronze or approved marble only.
4. Any inscriptions on a grave marker or monument shall be tasteful and not offensive. The City reserves the right to reject any such offensive or obscene monument, marker or inscriptions.
5. Foundations must be installed by the Public Works Department and are placed in line to conform with existing markers.
6. The City is not responsible for damage to monuments, markers, or stones in the cemetery caused by the ordinary care of the cemetery nor any other accident which may occur on cemetery property.

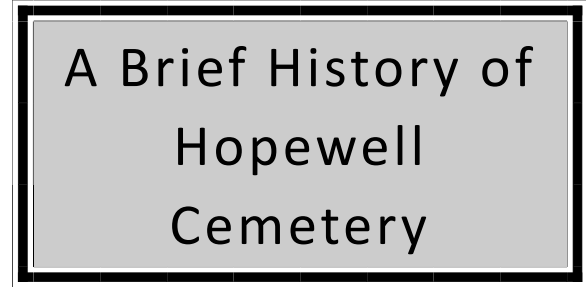

The Hopewell Cemetery, which was founded in 1803, is owned and operated by the City of Montgomery. Hopewell Cemetery is historically significant, serving as the burial location of many of the City's first settlers.

Among those who arrived in Montgomery in 1795, Cornelius Snyder, Jacob Roosa, and Nathaniel Terwilliger, are buried here, as well as five Revolutionary War veterans and over fifty Civil War veterans. The cemetery was created by the early settlers in the area as a place of respect, a means of honoring their triumphs and perpetuating the memory of loved ones. The oldest section of the cemetery is known as the "Pioneer Section" which was officially preserved as a Montgomery Landmark in 1978.



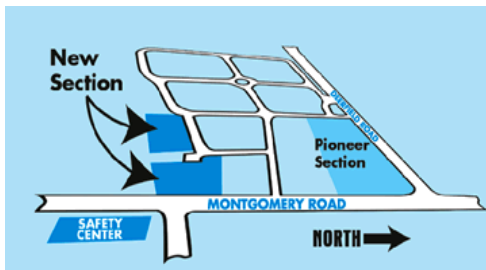
*Pioneer Section of Hopewell Cemetery*

**PURCHASE OF GRAVES**

1. Available cemetery graves may be purchased at 10101 Montgomery Road during normal office hours. Purchase of a deed to a grave is not a real estate purchase, but simply a right to bury someone in the cemetery. All land in the cemetery remains the property of the City of Montgomery.
2. A resident is not permitted to purchase a grave at the resident rate for a non-resident.
3. Any lot owner may grant permission, by written order, for the burial of someone other than immediate family member in his/her lot.
4. Control of graves may be transferred to the heirs of the deceased, but for continuance of ownership, the heir that has the deed in his or her possession controls the use of the graves. At all time the records maintained by the City are binding.

Upon the death of the recorded owner, the control of the unused or undersigned grave(s) shall go to the legally designed beneficiary(s). Proof that a person is the legally designed beneficiary will need to be provided to the City in a reasonable satisfactory form. If there is no beneficiary, it will follow the natural order of spouse, to children to parents.

5. The City may, at its discretion, repurchase grave space at the original purchase .

**BURIALS**

1. A “Burial-Transit Permit” for the deceased person must be provided by the funeral home.
2. Funeral arrangements must be coordinated through the City of Montgomery. The City must be notified forty eight (48) hours before interment. Phone 513-891-2424.
3. Interments are done Monday through Friday from 8:30 a.m. to 2:30 p.m. Saturday from 8:30 a.m. to Noon. No arrivals will be permitted after these times. There are no Sunday, or City recognized holiday, or holiday week-end burials. Upon a showing that exigent circumstances exists or that a hardship would result, the City can waive the burial restriction on Sundays and city-recognized holidays.
4. Charges from services are shown on the Rate Schedule and are subject to change. All charges must be paid at the time of interment. No burial will be allowed until the purchase price of the grave and all other fees are paid.
5. All interments of cremains must be placed in a sealed container constructed of solid materials not subject to deterioration or leakage. The City reserves the right to pre-approve any materials before burial.

6. All interments of full burials (caskets) must be placed in a concrete vault. The City reserves the right to pre-approve any materials before burial.
7. Only City of Montgomery employees are allowed to dig graves.
8. One cremation may be buried in one grave or one full-size grave can hold up to two containers of ashes. One cremation may also be buried in an occupied grave.
9. The cemetery personnel shall exercise due care in making a disinterment, but shall assume no liability for the damage to any casket, outer container or their contents incurred while making the disinterment or removal.

**DECORATIONS**

1. No planting of any vegetation (trees, flowers or shrubs) is permitted on graves.
2. Glass containers, fences, benches, flower pots, trellises, decorative stones, landscape timbers or other ornamentation or decoration are not permitted and shall be removed without notice.
3. Flowers and decorations will be removed from gravesites the first day of each month except those placed on monuments or in monument vases. Flowers and other decorations placed on graves are periodically removed when they become unsightly or for grass mowing and other maintenance.
4. Arrangements designed for attachment to markers are permissible, but shall be removed without notice when they detract from the general appearance of the Cemetery.
5. The City does not assume responsibility for flowers or other decoration on a grave site within the cemetery.
